- * Official Qualifying Week (6/13/2022 - 6/17/2022). Begins at noon and ends at noon. Remaining qualifying papers are submitted.
- * In School Board Races, if no candidate receives 50% + 1 votes, then the top two vote getters face each other in the General Election.
- * In Partisan races, if all candidates are of the same party the race is "winner take all" and decided in the Primary (AKA Universal Primary)
